- Reopened CFI's Learning Center after the COVID-19 closures and enrolled 98 children who have received supplemental Khmer, Math, English and Computer classes
- Supported 17 students with University Scholarships
- Provided vocational training to 9 students
- Supported 9 grade 9 and grade 12 students with exam preparation classes
